THE PERMIT ALLOWS: Melbourne Metro Rail Project Early Works Package: Including tree removal, bluestone kerb and guttering removal and replacement, service relocation and road works., in accordance with the following documents, as endorsed by the Executive Director and forming part of this permit: Early Works – Royal Parade MET605-G-MAP-036-D

THE FOLLOWING CONDITIONS APPLY TO THIS PERMIT:

- 1. Prior to the completion of the main works for the Metro Tunnel Project, all trees that have been removed are to be replaced to the satisfaction of the Executive Director. The replacement trees are to be super advanced plantings of the same species as those removed, with a minimum trunk diameter of 120mm and are to be located as close as practicable to the original locations within the boulevard form and planting of Royal Parade.
- 2. Prior to the replanting of the replacement trees required by Condition 1 of this permit, a detailed tree planting methodology and maintenance schedule is to be provided for the written approval of the Executive Director. The document shall show the proposed location of each of the replacement trees and must describe the manner in which each tree is to be planted and the measures that are to be taken to ensure the success of the replanting and the means by which the trees are to maintained.
- **3.** Prior to the completion of the early works for the Metro Tunnel Project all kerbing and guttering that was temporarily removed as part of works approved by this permit application is to be reinstated to the satisfaction of the Executive Director. Detailed documentation describing the layout, location and construction detailing of the kerbing and guttering is to be submitted for the written approval of the Executive Director prior to its installation. All bluestone kerbing and guttering proposed for temporary removal is to be photographically recorded to aid in its reinstatement. All removed bluestone kerbing and guttering is to be securely stored in a location approved by the Executive Director.
- 4. Prior to the commencement of works approved by this permit an unconditional Bank Guarantee in favour of the Heritage Council of Victoria (ABN 87 967 501 331) to ensure the satisfactory completion of the reinstatement works and documentation required by Conditions 1,2 &3 of this permit, regardless of the financial status of the Principal, is to be lodged with the Executive Director. The period of validity of the Bank Guarantee is to be unspecified. The Bank Guarantee is a

Completion Bond to ensure completion of reinstatement works to the place required by Conditions 1,2 & 3. The Bank Guarantee shall be released on written application to the Executive Director, subject to completion of the approved works to his satisfaction, and may be released in agreed stages (including following the reinstatement of the kerbing and guttering and then following the reinstatement of the four trees) as works progress at the completion of each stage. The liability for the Bank Guarantee is as follows (unless otherwise agreed in writing by the Executive Director):

- a) For the reinstatement of the kerbing and guttering a One Hundred and Thirty Thousand Dollar (\$130,000) bank guarantee payable by the Early Works Managing Contractor appointed by the Melbourne Metro Rail Authority to be returned to the Early Works Managing Contractor;
- b) for the re-instatement of the four trees a Forty Thousand Dollar (\$40,000) bank guarantee payable by the Melbourne Metro Rail Authority to be returned to the Melbourne Metro Rail Authority or respective works contractor (including the appointed PPP contractor) if agreed in writing by the Executive Director.

The Bank Guarantee shall be forfeited to the Heritage Council of Victoria if the reinstatement works are not completed to the satisfaction of the Executive Director by the expiration of this permit or as otherwise agreed in writing by the Executive Director.

- 5. This permit shall expire if the permitted works have not commenced within two (2) years of the date of issue of this permit, or are not completed within nine (9) years of the date of issue of this permit unless otherwise agreed in writing by the Executive Director, Heritage Victoria.
- **6.** The Executive Director is to be given five working days notice of the intention to commence the approved works.
- 7. Approved works or activities are to be planned and carried out in a manner which prevents damage to the registered place / object. However, if other previously hidden original or inaccessible details of the object or place are uncovered, any works that may affect such items shall immediately cease. The Executive Director shall be notified of the details immediately to enable Heritage Victoria representatives to inspect and record the items, and for discussion to take place on the possible retention of the items, or the issue of a modified approval.
- 8. All works must cease and this office be contacted if historical archaeological artefacts or deposits are discovered during any excavation or subsurface works. Should any munitions or other potentially explosive artefacts be discovered, Victoria Police is to be immediately alerted whilst the site is cleared of all personnel.
- **9.** The Executive Director is to be informed when the approved works have been completed.
- **10.** The development approved by this permit is to be carried out in accordance with the endorsed drawings, unless otherwise agreed in writing by the Executive Director, Heritage Victoria.

NOTE THAT PERMISSION HAS BEEN GIVEN FOR INSPECTIONS OF THE PLACE OR OBJECT TO BE UNDERTAKEN DURING THE CARRYING OUT OF WORKS, AND WITHIN SIX (6) MONTHS OF NOTIFICATION OF THEIR COMPLETION. TAKE NOTICE THAT ANY NATURAL PERSON WHO CARRIES OUT WORKS OR ACTIVITIES NOT IN ACCORDANCE WITH THE PERMIT OR CONDITIONS IS GUILTY OF AN OFFENCE AND LIABLE TO A PENALTY OF UP TO 2,400 PENALTY UNITS (\$346,464) OR 5 YEARS IMPRISONMENT OR BOTH, OR IN THE CASE OF A BODY CORPORATE 4800 PENALTY UNITS (\$692,928).

THE ATTENTION OF THE OWNER AND/OR APPLICANT IS DRAWN TO THE NEED TO OBTAIN ALL OTHER RELEVANT PERMITS PRIOR TO THE COMMENCEMENT OF WORKS.

WHAT HAS BEEN DECIDED?
